



Waiver/Release of Liability 2020

This agreement releases **Blue Sky Ranch, Inc.** from all liability relating to **ANY** injuries that may occur **during the Blue Sky Ranch Birthday Party (including set up or clean up). Events during the party may include the following: being around horses, being led around on a horse, activities in and around the arena, activities in or around the property (including but not limited to the very deep pond, ranch machinery, hay bales, horses, dogs, cats, hay rides, barns, hangars, docks, beaches, etc.) and/or any unsupervised personal time on the property or by the pond.** I also acknowledge the risks involved in **afore mentioned activities.** These RISKS may include but are not limited to: **physical injury and death.** By signing this agreement, I agree to hold **Blue Sky Ranch, Inc. and its agents** entirely free from any liability, including financial responsibility for injuries incurred, regardless of whether injuries are caused by negligence. I understand it is up to me to consult with physicians or other medical professionals to ensure that I/my child/my dependent can safely participate in activities and events during the Blue Sky Ranch Birthday Party. I understand and agree that I am relinquishing my right and the rights of my estate or heirs to make any claim of any nature against Blue Sky Ranch by participating in this party.

I swear that I am participating voluntarily, and that all risks have been made clear to me. Additionally, I do not have any conditions that will increase my likelihood of experiencing injuries while engaging in this activity.

By signing below, I forfeit all right to bring a suit against **Blue Sky Ranch, Inc. and its agents** for any reason. I will also make every effort to obey safety precautions as listed in writing.

I will ask for clarification when needed.

PHOTO RELEASE I certify that I am the age of majority and having the right to contract in my own name and on behalf of all minors on this Waiver, and to the extent herein set forth. I hereby irrevocably grant to Blue Sky Ranch, its successors and assigns, its agents and those by whom it is commissioned, the absolute, unrestricted and unlimited license, right, permission, and consent to use and reuse, disseminate, copyright, print, reproduce, publish and republish, for any and all trade purposes or commercial or other advertising or public purposes, and in any and all advertising, publicity, display, publication or media, my and my minor's names, signature and likenesses, and any portraits, pictures, photographic prints or other representations of me and/or my minors, or in which any may appear, or any reproductions or sketches thereof or parts thereof, photographic or otherwise, with such additions, deletions, alterations or changes therein as you in your discretion may make, either separately or together with names or fictitious names, or the name of another person, with or without any statements or testimonials made by me, or authorized by me which you may, in your discretion, prepare for use in connection therewith. I warrant that I have not limited or restricted the use of my or my minor's name or photograph to the use of any organization or person. I hereby grant unrestricted use of audio tracks or text by Blue Sky Ranch for such purposes as Blue Sky Ranch may deem appropriate. I hereby release and discharge Blue Sky Ranch, its successors, assigns and agents from any and all claims





and demands arising out of or in connection with the use of any of the foregoing, including any claims for defamation, invasion of privacy or violation of any statutory right.

I represent to Blue Sky Ranch, that neither I, nor anyone I am signing on the behalf of, are registered sex offenders in any legal jurisdiction and that furthermore, I have an affirmative duty to Blue Sky Ranch to immediately disclose to Blue Sky Ranch any change in registered sex offender status for myself or anyone I am signing for who seeks admittance at the Blue Sky Ranch Birthday Party. For the safety of all concerned, access to the property is denied to known registered sex offenders.

Notice: As part of our commitment to the safety of children and vulnerable persons, Blue Sky Ranch reserves the right to consult public sources to determine whether any member or guest of any member poses an unreasonable risk of harm to its patrons, staff, or visitors.
